### **WHY IS TRUCKING ATS CYBERSECURITY IMPORTANT?**

Because a trucking ATS handles sensitive applicant data, cybersecurity is of the utmost importance to prevent data breaches and ransomware attacks.

#### What is a ransomware attack?

When a company is the victim of a ransomware attack, attackers (also referred to as "ransomware gangs") encrypt a company's data and hold it for ransom. Companies can pay for the decryption key, or have an increased risk the stolen data will be shared.

#### Who is at risk for a ransomware attack?

Small and large trucking companies alike. Even though news headlines often feature stories about data breaches at large

companies, small companies are also often the victims of ransomware attacks.



## **HOW TO FIND A SECURE TRUCKING ATS AND PREVENT CYBERATTACKS**

## CHOOSE VENDORS WITH SOLID

Your trucking ATS should be able to point to a detailed audit or certification from a third party. If the ATS doesn't have a certification, that's a red flag.

Tenstreet has a team devoted to security. All applicant data is encrypted and internal audits are conducted to validate that the proper security controls are in place. Tenstreet invests hundreds of thousands of dollars per year in hardware, software, systems, training, and people to keep its trucking ATS platform and the data possessed/maintained by Tenstreet as safe and secure as possible.

#### **LOOK FOR THIRD-PARTY** VERIFICATION.

Vendors' security protocols should be audited by an independent party.

Each year, Tenstreet undergoes an SSAE-18 SOC2 Type II audit. SOC2 is an AICPA framework for auditing service providers. Through it, the provider's security controls are assessed against a common set of standards/principles to validate that they're designed and effectively implemented throughout the audit period to ensure the confidentiality, integrity, availability, and privacy of customer data.

# ENSURE YOUR TRUCKING ATS PROVIDER HAS

Data should be stored in multiple locations.

et: Tenstreet maintains multiple copies of all data and documents synced in real-time across geographic areas. As an additional level of redundancy and protection, Tenstreet also maintains backup routines that create offline backups not physically connected to any hardware. Backups help ensure systems that rely on the data would be restored in the event of a worst-case ransomware event.


